Oxfam at the 2025 G20 Summit in Johannesburg, South Africa

Oxfam experts and partners will be at the G20 Leaders' Summit in Johannesburg, South Africa (November 22 - 23), to call on world leaders to address extreme wealth inequality, tax the super-rich, cancel unsustainable debt, and mobilize fair climate finance for people and the planet.

Under South Africa's presidency and with the theme "Solidarity, Equality, and Sustainability," the 2025 G20 Summit comes at a critical moment as the world faces an inequality emergency, the rise of oligarchies, increasing debt crises and threats to multilateral cooperation.

US isolation under the Trump presidency and increasing global divisions have made the need for fair and inclusive international governance more urgent than ever.

This year's G20 also marks a historic moment: the second participation of the African Union as a full member and the first African Presidency. This offers a great opportunity to promote African-led development and justice at a global event.

The Oxfam delegation will be available to discuss several key issues:

- G20 leaders must renew their commitment to a global agenda for the effective taxation of the super-rich individuals, as well as a fairer international corporate tax system and end tax avoidance.
- G20 countries must cancel unsustainable debts and support South Africa's initiative on the cost of capital to create fiscal space for climate and development.
- Mobilize at least \$1.3 trillion per year in new grant-based climate finance, ensuring that the poorest nations can lead their own energy transitions.
- Create an alliance of progressive countries, led by South Africa, Brazil, and Spain, to defend multilateralism and promote fair global economic reform.
- Support South Africa's proposal to create an Extraordinary Committee of Independent Experts to warn about global wealth inequality.

Inspired by South Africa's rugby legacy, the scene shows a united team photo symbolizing global cooperation: Brazilian President Lula, who secured the **first-ever global consensus at last year's G20 to tax the super-rich**, passes a giant rugby ball emblazoned with the **message to President Ramaphosa** - signaling the handover of leadership on this agenda. Around them, other G20 leaders gather as part of the team, displaying different attitudes. This powerful image offers compelling visuals and a clear message: it's time for world leaders to play as one team and deliver on taxing the super-rich.
